November 2011 the During society successfully ran its 3rd annual conference (ABNMS2011) at Queensland University of Technology (QUT), Gardens Point Campus. Prior to the conference we ran a 2 day tutorial covering BN basics and commonly used software, BN and GIS integration, object oriented BNs, and BN structure and parameter learning. At the conference itself we had 30 attendees and 14 presentations over 2 days covering applications in health, transport and the environment, as well as risk assessment and BN methods. It is great to see the growing interest in BN modelling in Australasia and the continued development of BN methodologies and software.

As always, membership and conference registration fees for the society are quite low. Full membership is only \$50 per year and student membership is free. The format for the conference this year will be a 2 day pre-conference Bayesian network tutorial (26th and 27th of November) followed by a 2 day conference in which there will be poster and paper presentations and discussions (28th and 29th of November). Papers are invited from all fields including environmental management, engineering, law, infrastructure and medicine. Three special sessions will be incorporated into this year's conference:

1. Integration of geospatial data and Bayesian Networks;

2. Emerging methods and tools for Bayesian Networks; and

3. Expert elicitation of data.
